- ONE:** The name and address of this principal corporation is M & M Scott Ministries, Inc. 751 S.W. 70th Way North Lauderdale, Florida 33068. The corporation is organized pursuant to the **FLORIDA** Non-profit Corporation Code.
- TWO:** This corporation is a non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Public Benefit Corporation Law for Religious purposes. To establish structured support service for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the corporation creed/by-laws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic Development Programs, but, shall not be limited to: Homelessness, Health Care, Child Care, Youth At High Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.

- (a) This corporation is organized and operated exclusively for Religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

SIX: The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:

Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
