

Articles of Incorporation of SageWays Center, Inc.

Article I: Name

The name of the organization will be SageWays Center, Inc., hereinafter referred to as the Corporation.

Article II: Principal office and/or mailing address

The address of the principal office of the Corporation is 230 Royal Palm Way, Suite 405, Palm Beach, FL 33480.

Article III: Purpose

SageWays Center, Inc. is a not-for-profit corporation, organized for the purpose of the interdisciplinary exploration of the whole person - body, mind and spirit, which will include education, research, treatment and other activities related to enriching the totality of human life, and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not-for-profit corporations may be organized, so far as is or may be permitted by the laws of the State of Florida and Section 501[c][3] of the Internal Revenue Code of 1986, as amended.

Article IV: Membership

Any person, corporation, partnership, association or organization, who is interested in the purposes of the Corporation, who is capable of contributing to the achievement of those purposes and the effective operation of the Corporation, shall be eligible for membership. Special categories of membership, with attendant requirements may be established from time to time by the Board of Directors. No share certificates will be issued.

Article V: Initial Registered Office and Agent

The street address of the initial registered office of the Corporation is 230 Royal Palm Way, Suite 405, Palm Beach, FL 33480; and the name of the Corporation's initial registered agent at that address is: Eloise F. Nenon, SageWays Center, 230 Royal Palm Way, Suite 405, Palm Beach, FL 33480.

Article VI: Board of Directors

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than three [3] directors. The number of directors may be increased or decreased from time to time, in accordance with the Bylaws of the Corporation, but shall never be less than three. Article VII: Dissolution

Upon the dissolution or winding up of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501[c][3] of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

Article IX: Limitations

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation [except as otherwise provided in subsection [h] of Section 501 of the Internal Revenue Code of 1986], and the Corporation shall not participate or intervene in [including the publishing or distributing of statements] any political campaign on behalf of any candidate for public office.
