ARTICLES OF INCORPORATION

New Generation Christian Center, INC.

The Undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

Article I: Name

The Name of this corporation shall be "New Generation Christian Center Inc."

Article II: Address

The principle place of business and worship of this corporation shall be 123 Canal Street, Tallahassee, Florida 32301.

Article III: Purpose

The general purpose of this corporation is to establish and operate a Church and associated auxiliary programs. New Generation Christian Center Inc., shall subscribe to the Tenets of Faith as described in the By-Laws of this corporation. This corporation shall operate exclusively for such religious, charitable and educational purposes as qualify as a non for profit, tax-exempt organization under federal and state law, which may include but not limited to church and worship services, Sunday school programs, nursery and day care schools and/or centers and/or programs, children and youth services and programs, outreach programs, educational programs and institutions or any other programs and auxiliaries which will advance our religious beliefs, relieve the poor and distressed as well as diligently make every effort to reduce tension in the community.

Article IV: Directors

The directors of this corporation shall be the trustees, directors and advisors and may be elected or appointed or dismissed as regulated by the by-laws of the corporation.

Article V: Powers

This corporation shall have all the powers, rights and privileges of a not for profit corporation as described in Section 617.0302, Florida Statutes.

Article VI: By-Laws

The Directors of this corporation shall adopt and publish by-laws to govern this not for profit corporation and must submit to operate and conduct corporate business as regulated in those bylaws.

Article VII: Registered Agent

The initial registered agent of this non-profit corporation shall Rev. David Jones and the initial registered office of this non-profit corporation shall be 123 Canal Street, Tallahassee, Florida 32301.


