# **ARTICLE I**

#### NAME

The name of the Corporation is The Federation of Liberian Associations of Florida, Inc.

# ARTICLE II

#### DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

# ARTICLE III

# PURPOSE

a. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statues. It is not organized for the private gain of any person. The specific purposes of this corporation are:

- (1) The Federation is to represent the Liberian Associations of Florida on a national and international level to promote the aims and aspirations of the Liberian Associations of Florida.
- b. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- c. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make and distribution in furtherance of its stated purposes.

# ARTICLE IV

#### QUALIFICATIONS OF MEMBERS

The qualifications of members of this corporation and the manner of their admission shall be regulated by the bylaws of said corporation.

# ARTICLE V

#### INITIAL REGISTERED OFFICE AND AGENT
