ARTICLES OF INCORPORATION  
OF  
FLORIDA YOUNG DEMOCRATS SUMMER CONVENTION, INC.

The undersigned incorporator hereby forms a not-for-profit corporation under Chapter 617 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

FLORIDA YOUNG DEMOCRATS SUMMER CONVENTION, INC.

ARTICLE II. PLACE OF BUSINESS

The address of the principal office of this corporation shall be P.O. Box 11213, Tallahassee, FL 32302, and the mailing address of the corporation shall be the same.

ARTICLE III. SPECIFIC PURPOSE

This corporation may engage in every aspect of the hosting, developing and coordinating in the Florida Young Democrats Summer Convention for the Host County Club and the Florida Young Democrats. 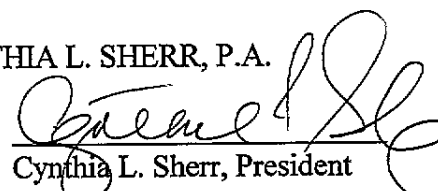

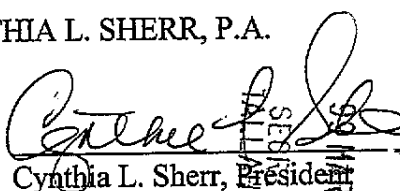
