# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a nonprofus corporation in accordance with Chapter 617 of the Florida Statutes, does hereby make and adopt the following Articles of Incorporation:

# ARTICLE ONE

THE REGAN C. WHITE MEMORIAL FUND, INC.

The name of the Corporation is The Regan C. White Memorial Fund, Inc.

# ARTICLE TWO

## DURATION

The term of existence of the Corporation is perpetual, and the corporate existence will commence on the filing of these Articles by the Department of State.

#### ARTICLE THREE

#### NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its members, directors, or officers except to the extent permissible under law.

#### ARTICLE FOUR

# PURPOSE

The purposes for which the Corporation is organized are:

A. The mission of this Corporation is to assist in preserving and/or enhancing the quality of life of children,

- C. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable to accomplish the purposes.
