rendered and to make payments and distributions in furtherance of section 501 (C) (3) purposes. No substantial part of the activities

of the organization shall not participate in or intervene in (including the publishing or distribution of statements) any political

campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles

the organization shall not carry on any other activities not permitted to be carried on (a) by a organization exempt

from federal income tax under section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future

Federal tax code) or (b) by a organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue

Code (or corresponding section of any future Federal tax code). Upon the dissolution of the Miracle Temple Ministries of Hollywood, Inc.

assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code,


