**ARTICLES OF INCORPORATION**  
**FOR**  
***JCBabies, Inc.***

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I NAME**

The name of the corporation shall be: JCBabies, Inc.

**ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

**ARTICLE III PURPOSE**

The specific purposes for which the corporation is organized are:

*Section 1.* The purpose of this corporation will be to minister and educate the general public on Biblical values and beginning relationships with Jesus Christ. The corporation will be developed through publications, committees, projects and a ministry to serve God.

## **ARTICLE IV MANNER OF ELECTION OF DIRECTORS**

The manner in which the directors are elected or appointed is as follows:

*Section 1.* The chapter shall be managed by a Board of Directors. Each Director shall be at least 18 years of age.

*Section 2.* The officers of the Board of Directors shall be the chapter President, Vice President and Secretary/Treasurer offices.

*Section 3.* Officers shall be elected for a two year term. Elections shall be held every other year beginning February 2000.

*Section 4.* Any member in good standing is eligible to serve as an officer of this organization.

*Section 5.* A nominating committee of three persons chosen from the Board of Directors shall select one nominee for each office.

- a. Additional nominations may be made from the floor.
- b. Consent of nominee must be obtained prior to nomination.
- c. If there is only one nominee for each office, election may be by voice.
- d. Board members shall be elected by a majority vote of the Board.

*Section 6.* A member in good standing, for purposes in consideration of Board Membership, must be a Christian following Jesus Christ, regularly attending a church prior to election to an office. This person shall adhere to JCBabies Inc. by-laws and dictates in all associations with JCBabies Inc. work. In cases of Board members non compliance, they may be put on probation for 3 months by a majority vote of the board to determine if there is adequate cause for dismissal from the board. A majority vote is required for dismissal.

*Section 7.* Vacancies occurring in office shall be filled by the majority vote of the Board for the remaining term.

## **ARTICLE V LIMITATION OF CORPORATE POWERS**

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes.


