ARTICLES OF INCORPORATION

OF

BAY HIGH SCHOOL BASKETBALL BOOSTER CLUB, INC.

A Corporation not for profit

ARTICLE I

This corporation shall be known as **Bay High School Basketball Booster Club, Inc.**

ARTICLE II

The principal place of business and mailing address of the corporation is 1021 Grace Avenue, Panama City, Florida 32401.

ARTICLE III

This corporation shall commence upon filing and shall have perpetual existence. This corporation is organized on a non-stock basis.

ARTICLE IV

The corporation's primary purpose shall be the operation, management, promotion, and continuation of the Bay High School basketball booster program. It shall have the purpose of promoting and furthering any high school athletic or sporting events in Bay County, Florida and the promotion of general charitable purposes.

ARTICLE V

The corporation shall have all powers provided by law for such corporations.

ARTICLE VI

The street address of the initial registered office shall be: 1021 Grace Avenue, Panama City, Florida 32401, and the name of the initial registered agent shall be: Chris Patterson.

ARTICLE VII

The officers of the Corporation shall consist of a president, a vice-president, a secretary, a treasurer, and such other officers, as the Board of Directors may from time to time deem advisable. Any two offices may be held by the same person. The officers of the Corporation shall be elected by the members at the regular annual meeting of the Board.


ARTICLE VIII

The election of the board of directors shall be conducted in the manner provided in the By-Laws of Bay High School Basketball Booster Club, Inc.

ARTICLE IX

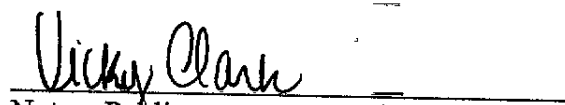

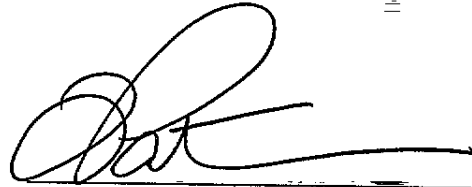
