ARTICLES OF INCORPORATION

OF

ARTICLE I

This corporation shall be known as Bay High School Basketball Booster Club, Inc.

ARTICLE II

The principal place of business and mailing address of the corporation is 1021 Grace Avenue, Panama City, Florida 32401.

ARTICLE III

This corporation shall commence upon filing and shall have perpetual existence. This corporation is organized on a non-stock basis.

ARTICLE IV


