## ARTICLES OF AMENDMENT OF THE CHARTER OF LIVING WORD COMMUNITY HUMAN SERVICES, INC.

The following amendment to the articles of incorporation of LIVING WORD COMMUNITY HUMAN SERVICES, INC., charter number N99000001533, were unanimously adopted by the Board of Directors on July 20, 1999, and the members of the corporation to amend the original Article III to read as follows:

## ARTICLE III: PURPOSE

The specific purposes for which the corporation is organized are exclusively religious, Α. charitable, scientific, literary and educational within the meaning of § 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this organization shall not carry on **B**. any activities not permitted to be carried on by an organization exempt from Federal income tax under § 501 (c) (3) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue law.

In the event of dissolution, the residual assets of the corporation will be turned over to C. one or more organizations which themselves are exempt as organizations described in §§ 501 (c) (3) and 170 (c) (2) of the Internal Revenue code of 1986 or corresponding sections of any prior or future Internal Revenue Code or to the Federal, State or local government for exclusive public purpose.
