ARTICLES OF AMENDMENT OF PH 4: 34 THE FIRST TEE OF JACKSONVILLE, INC. STATE

These Articles of Amendment are filed pursuant to Florida Statutes Section 607.1006, to reflect an amendment to the Articles of Incorporation of THE FIRST TEE OF JACKSONVILLE, INC., a Florida non-profit corporation (the "Corporation"), and in connection therewith, the undersigned officer, acting upon the authority of the Board of Directors of the Corporation, hereby sets forth as follows:

- 1. The name of this Corporation is THE FIRST TEE OF JACKSONVILLE, INC.
- 2. The Articles of Incorporation of THE FIRST TEE OF JACKSONVILLE, INC. have been amended by deleting Article I in its entirety and by substituting the following in lieu thereof:

"ARTICLE I. NAME

The name of this Corporation is: The First Tee of North Florida, Inc."

- 3. In accordance with Florida Statutes Section 607.1003, the referred to Amendment was adopted by the Board of Directors of the Corporation on February 15, 2013.
- 4. In accordance with Article VI of the Corporation's Articles of Incorporation, the Corporation has no shareholders or members and, accordingly, the Board of Directors has the sole authority to adopt this Amendment.
- 5. Upon the filing of these Articles of Amendment by the Department of State, the above referred to Amendment shall become effective and the Articles of Incorporation of the Corporation shall be deemed to be amended accordingly.
