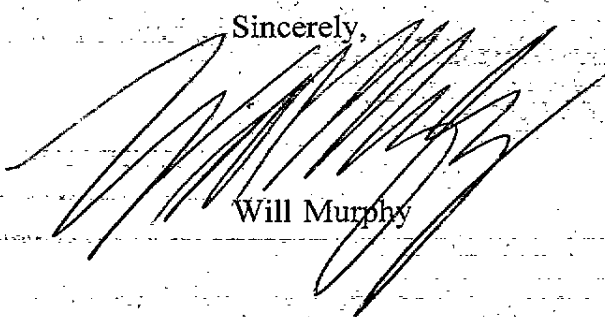

OF

**ARTICLE I: CORPORATE NAME**

The name of this corporation is SOUTH FLORIDA PADDLERS, INC.

**ARTICLE II: NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this corporation is to operate a not-for-profit association of persons interested in the paddling sports, including but not limited to kayaking and canoeing, to promote safe and responsible use of waterways, to provide benefits to the members of said association and all lawful purposes reasonably related to the aforementioned functions.

**ARTICLE III: TERM OF EXISTENCE**

This Corporation shall have perpetual existence.

## **ARTICLE V: BOARD OF DIRECTORS AND MANNER OF ELECTION**

This Corporation shall have 5 Director initially. The number of Directors may be increased or diminished from time to time by way of bylaws adopted by a two-thirds vote of all directors, but shall never be less than three (3). Directors and officers shall be elected by majority vote of members of the association present at the annual meeting of members to be held between 15 January and the last day of February each calendar year beginning the year 2000. Directors and officers shall serve a term of one (1) year, commencing on the date of their election and ending on the date their successor is elected.
