ARTICLE I

NAME

The name of the Corporation is **God's Dominion Ministry, inc...**

ARTICLE II

DURATION

This Corporation shall have perpetual existence commencing on the date of this filing of these articles with the Department of State.

ARTICLE III

PURPOSE

The corporation is not organized for pecuniary gain or profit and is organized under the Florida Corporations Not for Profit Code for the specific and primary purpose of operating for the advancement of faith under christian principles which shall include, but shall not be limited to, the following:

- (A) To conduct worship services in the manner prescribed in the New Testament;
- (B) To edify christians with teachings of the Scriptures;
- (C) To preach the gospel of Jesus Christ;
- (D) To seek universal fellowship with christians for the testimony of God;
- (E) To minister spirtual and temporal needs of the poor, sick, orphans and widows according to brotherly love inspired by God;
- (F) Th engage in home and foreign missionary activities in cooperation with affiliated local churches in furtherance of the hereion described purposes; and
- (G) To perform an operation and to conduct and top conduct and perform any and activities that may be related, no matter how remote, to any of the foregoing.

ARTICLE IV

Qualifications of members

The qualifications of members of this corporation and the manner of their admission shall be regulated by the bylaws of said corporation.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT

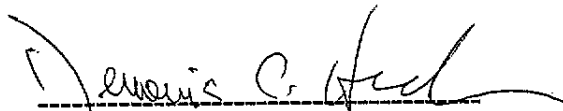
