ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be **Good and Faithful Servants, Inc.**

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE(S)

Said corporation is formed exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Specifically, the corporation is organized for the purpose of teaching biblical principles of stewardship and total life management to the public by producing seminars, facilitating group bible discussions, providing educational material and resources published in forms, including but not limited to pamphlets, newsletters, books, audio cassette tapes and video tapes.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS:

A Board of Directors shall manage the activities and affairs of the corporation. They may have powers to authorize the seal of the corporation. The number of directors which shall constitute the whole Board shall in no case be less than three. The Board of Directors shall be elected by the members at the annual meeting of the corporation to be held on such date as the Bylaws may provide, and shall hold office until their successors are elected.
