ARTICLES OF INCORPORATION

OF

PALM COAST JOINT TRAINING ASSOCIATION, INC.



ARTICLE I - NAME

The name of this nonprofit corporation is PALM COAST JOINT TRAINING ASSOCIATION, INC. The principal place of business shall be at 4620 Summit Boulevard, West Palm Beach, FL 33415.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This nonprofit corporation is organized exclusively for educational purposes, including, the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any further Federal tax code) or (b) by a corporation, contributions to which are deductive under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any further Federal tax code).

ARTICLE VI - INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office of this nonprofit corporation shall be 1850 Forest Hill Blvd., Suite 101, West Palm Beach, FL 33406, and the name of the initial registered agent of this corporation at such office shall be Ronald K.
