BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation not for profit under Florida law.

ARTICLES I
NAME

The name of the corporation shall be MIAMI SOUTH CHURCH OF CHRIST, INC., hereinafter referred to as the Corporation.

ARTICLES II
DURATION

The duration of this corporation shall be that it exist perpetually.

ARTICLES III

ARTICLE VIII


