

# ARTICLE I

The general nature and the object and purpose of this corporation shall be to promote knowledge and practice of safe flying and to make low-cost flying available to its members on a nonprofit basis.

### ARTICLE II

This corporation shall have perpetual existence unless sooner dissolved by law.

### ARTICLE III

The principal office of this corporation shall be located at 35213 S.R. 54 W.; Zephyrhills, Florida 33541. The Board of Directors may, from time to time, move the principal office to any other address and may establish branch offices and other places of business as may be deemed expedient.

### ARTICLE IV

The business of this corporation shall be conducted by its Board of Directors. This corporation shall have a minimum of five (5) directors and no more than thirteen (13) directors. Each director shall hold office until his successor shall be elected and qualified. ### ARTICLE VIII

The officers shall manage the affairs of the Corporation, and they shall be elected as provided in the By-Laws of this Corporation.

### ARTICLE XI

In the event of dissolution of this Corporation, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code or to the federal, state or local government for exclusive public purpose.

Notwithstanding any other provisions of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law, or (b) a

corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code or any other corresponding provision of any future United States Internal Revenue Code.
