ARTICLES OF INCORPORATION

FOR

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of incorporation:

ARTICLE I - NAME

The Name of the corporation shall be:

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS:

ARTICLE III - PURPOSE

The specific purposes for which the corporation is organized are:

- 1- This Church is organized for the purpose of "Glorify God in the Salvation of Souls, the Edification of the Gospel of the Lord Jesus Christ, the promotion of Godly Worship, the defense of the Faith once delivered, and cooperation with Christian Activities functioning in harmony with God's Holy Word, Campaigns and other Christian activities as to provide Food, Toys, Clothes to the poor people of the Greater Miami until Jesus comes.
