ARTICLES OF INCORPORATION

OF'

NEW LIFE COMMUNITY CHURCH OF PINELLAS COUNTY, INC.

The undersigned, DIXIE EARL GLISSON, JR., LARRY SIPE and DAVID M. RICE, do hereby associate themselves together to form and establish a corporation, not for profit, pursuant to Chapter 617 of the Florida Statutes.

ARTICLE I. NAME

The name of the corporation shall be NEW LIFE COMMUNITY CHURCH OF PINELLAS COUNTY, INC.

ARTICLE II. PLACE OF BUSINESS

The location of the principal office is: 1773 Biarritz Circle, Tarpon Springs, Florida 34689. The mailing address of the corporation is Post Office Box 6182, Palm Harbor,—Florida 34687-6182.

ARTICLE III. PURPOSE

- A. This Corporation is organized NOT for profit.
- B. The purpose of the corporation shall be to exalt Jesus Christ and encourage others to do the same through gathering for public worship; giving instruction and application of the truths, practices and principles of the Christlan Bible and life skills consistent therewith; providing physical, emotional, and spiritual aid to both its members and community at large; receiving gifts and grants of money and property of every

kind for the purpose of fulfilling the activities mentioned

above, in addition to supporting agencies and individuals who do

likewise.

C. In addition to the foregoing, this corporation shall have the power to perform any and all lawful acts established pursuant to Chapter 617 of the Florida Statutes.

ARTICLE IV. TERM OF EXISTENCE

This corporation is to exist perpetually, unless sooner voluntarily dissolved according to law.

ARTICLE V. ELECTION OF DIRECTORS

The business of this corporation shall be managed by a Board of Directors. The number of Directors shall be as few as three (3) and not more than seven (7).

A. This corporation shall have three (3) directors initially. The initial directors shall be the incorporators listed herein (Article X). The number of Directors may increase or decrease from time to time in accordance with the By-Laws adopted by the stockholders. Directors shall be of legal age and then shall be elected pursuant to the By-Laws.

ARTICLE VI. BY-LAWS

The Directors of this Corporation shall provide By-laws for the conduct of its business and the carrying out of its purposes. The By-Laws may be amended or rescinded by a majority vote of those members of the Board of Directors at any regular

meeting or any special called meeting; provided that notice has been given in accordance with the By-Laws.

ARTICLE VII. NON-PROFIT

No profit shall ever accrue to the benefit of any individuals from the assets, holdings or other transactions in which this corporation may become involved

ARTICLE VIII. POWERS

Corporate powers of this corporation are as_provided in Chapter 617 of the Florida Statutes.

ARTICLE IX. REGISTERED AGENT

The initial registered office of the corporation will be located at 1773 Biarritz Circle, Tarpon Springs, Florida 34689; and the name of the initial registered agent shall be DIXIE EARL GLISSON, JR.
