ARTICLES OF INCORPORATION
OF
C & L NORCROSS, INC.
A CORPORATION NOT FOR PROFIT

The undersigned does hereby execute these Articles of Incorporation for the purposes of forming a not for profit Corporation pursuant to the Florida Corporations Not For Profit Law set forth in Section 617 of the Florida Statutes.

ARTICLE I

CORPORATE NAME

The name of the Corporation is C & L Norcross, Inc.

The principal office and mailing address of the Corporation is 1500A Elizabeth Avenue, West Palm Beach, Florida 33401.

ARTICLE II

DURATION

The period of duration of this Corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon the filing of these Articles of Incorporation.

ARTICLE III

PURPOSES

This Corporation does not contemplate pecuniary gain or profit to its officers and directors and shall make no distributions of income to its officers and directors. The specific purposes for which it is formed are to (i) solicit and receive contributions from the public and to (ii) hold, manage and disburse such contributions received for the benefit of those persons who are suffering from brain tumors medically diagnosed as astrocytoma and/or oligodendroglioma and who reside in the City of West Palm Beach, County of Palm Beach, State of Florida, limited

to the purpose of eliminating the brain tumors by application of Antineoplaston therapy or any other medical treatments as an alternative to chemotherapy, as determined in the discretion of the Board of Directors of the Corporation.

ARTICLE IV

MEMBERSHIP

The Corporation shall have no members and shall not issue stock.

ARTICLE V

REGISTERED OFFICE AND AGENT

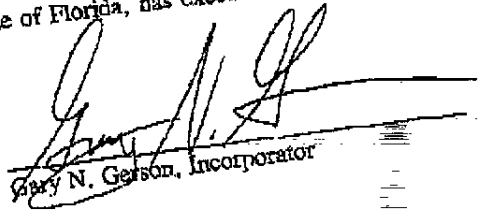

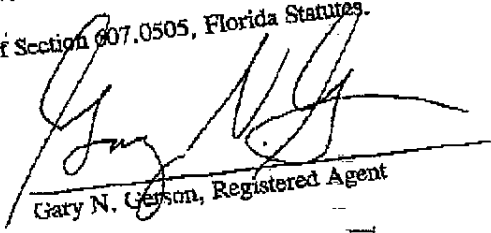
