The following constitutes Article of Amendment amending the Articles of Incorporation of SUNCOAST TRAILBLAZERS, INC., a corporation not-for-profit organized and existing under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as filed by the Secretary of State of Florida on March 15, 1999 ("Articles"). Said amendments were adopted by the members of the corporation entitled to vote thereon at a duly-called meeting of the membership of the corporation held on April 1, 1999, at which a quorum was present, and the number of votes cast for all amendments was sufficient for approval.

ARTICLE I

Article VIII of the Articles is amended to read in its entirety as follows:

ARTICLE VIII. BYLAWS


Section 1. The members of this corporation may provide such bylaws for the conduct of its business and the carrying out of its purposes as they may deem necessary from time to time.
