

**ARTICLES OF INCORPORATION
FOR
NORTH GREENWOOD COMMUNITY FAMILY CENTER, INC.**

- I. **CORPORATE NAME** - The name of the Corporation is:
NORTH GREENWOOD COMMUNITY FAMILY CENTER, INC.
- II. **PRINCIPAL OFFICE** - The *North Greenwood Community Family Center, Inc.* principal place of business shall be:

The Board of Directors may, from time to time, move the address to any other address in the State of Florida.
- III. **PURPOSE** - The purpose for which *NORTH GREENWOOD COMMUNITY FAMILY CENTER, INC.* is organized are exclusively religious, charitable, scientific, literary, cultural and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Furthermore, the *North Greenwood Community Family Center, Inc.* will seek to address the following core services, primarily in the North Greenwood area: Parent support and skills training; family literacy services; economic development activities; child development activities; linkages to the health care system; outreach; and usage for meetings/activities.
- IV. **MANNER OF ELECTION OF DIRECTORS** - The Directors shall be elected or appointed as provided in the bylaws of the Corporation.
- V. **LIMITATION OF CORPORATE POWERS** - Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
