KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, for the purpose of forming a corporation under the Corporation Code of the State of Florida, also known as the General Non-Profit Corporation Law, do certify:

**ARTICLE 1**

**NAME**

The name of the corporation shall be ASSOCIATION OF KOREAN BAPTIST CHURCHES OF FLORIDA, INC.

**ARTICLE 2**

**PURPOSES**

That this corporation is formed and shall be operated exclusively for charitable, religious and educational purposes.

**ARTICLE 3**

**GAINS AND PROFITS**

That this corporation does not contemplate the distribution of gains, profits or dividends to the members thereof, and that no part of the earnings of the corporation shall inure to the benefit of any members, trustee, officer or individual.

**ARTICLE 4**

**PRINCIPAL OFFICE**



#### **DISSOLUTION OF CORPORATION**
