

# ARTICLES OF INCORPORATION FOR

## The National United Parents Alliance, Inc.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation shall be: The National United Parents Alliance, Inc.

#### ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

#### ARTICLE III PURPOSE

The specific purposes for which the corporation is organized are:

Section 1. The purpose of this organization shall be to educate its members and the general public on matters of decency in American society, and to encourage affirmative action for decency. The purpose shall be developed through publications, letters, committees, conferences, projects and programs.

#### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

- Section 1. The Corporation shall be managed by a Board of Directors. Each Director shall be at least 18 years of age.
- Section 2. The officers of the Board of Directors shall be the President, Vice President, Secretary, and Treasurer and a maximum of five additional directors.
- Section 3. Officers and Board members shall be elected for a two year term. Elections shall be held every other year beginning June 2001.
- Section 4. Any member in good standing is eligible to serve as an officer of this organization.
- Section 5. A nominating committee of chosen from the Board of Directors shall select one nominee for each office.
  - a. Additional nominations may be made from the floor.
  - b. Consent of nominee must be obtained prior to nomination.

- c. If there is only one nominee for each office, election may be by voice.
- d. Board members shall be elected by a majority vote of the Board.

Section 6. A member in good standing, for purposes of consideration of Board Membership, shall be a Judeo-Christian, regularly attending a church, who has been active or supportive of The National United Parents Alliance, Inc. prior to election to office. This person shall adhere to The National United Parents Alliance, Inc. by-laws and dictates in all associations with The National United Parents Alliance, Inc. work. In cases of Board members non compliance, they may be put on probation for 3 months by a majority vote of the board to determine if there is adequate cause for dismissal from the board. A majority vote is required for dismissal.

Section 7. Vacancies occurring in office shall be filled by the majority vote of the Board for the remaining term.

#### ARTICLE V LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes.
