The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - Name

The name of the Corporation is Kissimmee Valley Trail Ride, Inc.

ARTICLE II - Initial Principle Office

The address and the initial principle office of the Corporation is 1300 Mac Overstreet Road, Kissimmee, Florida 34746.

ARTICLE III - Purpose
