#### HELPING TO KEEP DREAMS ALIVE CORPORATION

In compliance with the requirements of Florida Statutes, Chapter 617, the undersigned serves as incorporator, for the purpose of forming a corporation not-for-profit and does hereby certify:

#### ARTICLE I: NAME OF CORPORATION

The name of the corporation is Helping To Keep Dreams Alive Corporation (hereinafter called the "Corporation").

## ARTICLE II: PRINCIPAL OFFICE OF THE CORPORATION

The address of the principal office of the Corporation shall be 11403 Woodchuck Lane, Boca Raton, Florida 33428, and the mailing address shall be 11403 Woodchuck Lane, Boca Raton, Florida 33428.

# ARTICLE III: REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the Corporation is 11403 Woodchuck Lane, Boca Raton, Florida 33428. The name of the initial registered agent at that address is Edward Fineman.

# ARTICLE IV: PURPOSES AND POWERS OF THE CORPORATION

This Corporation does not contemplate pecuniary gain or profit to its members, and the specific purposes for which it is formed are as follows:

- (1) exclusively for charitable, educational, religious and/or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or under any corresponding provisions of any subsequent federal tax laws governing the distributions to organizations qualified as tax-exempt; and
- (2) except as limited by the Articles of Incorporation and the Bylaws, the Corporation will have and exercise all rights and powers in furtherance of its purposes as are or may hereafter be conferred on not for profit corporations pursuant to Chapter 617, Florida Statutes, and in accordance with other applicable law; and
- (3) initially the Corporation will devote its efforts and resources to (i) educating at-risk and underprivileged children in impoverished areas of Dade County (including Overtown, Carol City and Liberty City) regarding aspects of life and opportunities that they otherwise would not see or experience, (ii) assisting the aforementioned children in realizing that the negative influences and

surroundings in their lives can be overcome, and (iii) giving the aforementioned children hope that their futures can be happy and successful despite the negative influences. Eventually the Corporation intends to expand its efforts to help similarly impoverished areas throughout the State of Florida.

Notwithstanding any other provision of these Articles of Incorporation, this Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

#### ARTICLE V: MEMBERSHIP

This Corporation shall not have members.

## ARTICLE VI: BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by its Board of Directors. The initial Board of Directors shall be composed of three (3) members whose replacements shall be named pursuant to the method of election or appointment of the Board of Directors as stated in the Bylaws of the Corporation. #### ARTICLE VII: DISSOLUTION

A majority of the Board of Directors may authorize dissolution of the Corporation. After dissolution is authorized, the Corporation must file articles of dissolution, in compliance with Section 617.1403, Florida Statutes, with the Department of State.

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

#### ARTICLE VIII: DURATION

The Corporation shall exist perpetually.

## ARTICLE IX: AMENDMENTS

A majority vote of the Board of Directors may amend the Articles of Incorporation.

## ARTICLE X: BYLAWS

The Bylaws of this Corporation shall be adopted by the Board of Directors on behalf of the Corporation and may be altered, amended, or rescinded by a majority vote of the Board of Directors.
