ARTICLES OF INCORPORATION OF

(a corporation not for profit)

We, the undersigned, with other persons being desirous of forming a corporation for charitable and philanthropic purposes, under the provision of chapter 617 of the Florida Statutes, do agree to the following;

ARTICLE I

ARTICLE III

ARTICLE X

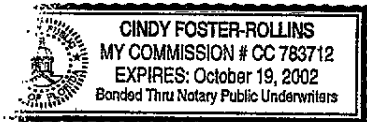
