ARTICLES OF INCORPORATION OF

EAGLE WINGS TEACHING MINISTRIES OF CHRIST, INC.-INTERNATIONAL

PREAMBLE

THE VISION Habakkuk 2:2

Whereas, God has in these last days founded His Church Upon Christ Jesus, (Matt. 16:13-18, Ephesians 2:19-22, I Corinthians 3:11), built it through His people (I Corinthians 3:5-15, I Corinthians 12:12-31), gave it power and authority (Acts 1:8, Acts 2:1-11, Matthew 16:19), and unified it with internal structure (I Corinthians 12:27-31) and the Holy Ghost as its guide (John 16:13-15), that we, as the body of Christ (Ephesians 1:22-23, Romans 12:5), might present His full gospel (Matthew 28:18-20, Mark 16:15-18) by assisting in the implementation of the vision for this SPIRIT-FILL EVANGELICAL RELIGIOUS, CHARITABLE, and EDUCATIONAL MINISTRY to which these following articles of incorporation are enacted. Eagle Wings Teaching Ministries of Christ, Inc.-International, a vision begun Oct. 17, 1982 by Elder Donald A. Horne, Sr., Evangelist Ella M. Anderson-Horne (his wife) and their four children (Carolyn, Carol, Caroline and Donald, Jr.). Its primary goal is the evangelical teaching of the Spirit-Fill Gospel of Christ Jesus and His apostles for victorious living, via biblebase academies, ministry training facilities, evangelistic outreachs, missionary outreachs, biblical study hours, weekly power and praise services.

We, whose names appear upon the voting membership roll of this ministry, in order to establish and maintain a place for the praise and worship of Almighty Jehovah God, our Heavenly Father, Creator and Supreme ruler of all Worlds, do hereby recognize ourselves as a sovereign religious, charitable, and educational ministry. We desire to provide Spirit-Fill Teaching Ministries of Christ Churches and Teaching Ministries of Christ Fellowships (Parachurch Ministries) of service for those of like precious faith and others, where the Lord Christ Jesus, through the Holy Spirit may be honored according to our distinctive witness (Matt. 28:18-20, Mark 16:15-18, Jo. 17:20, Act 1:8); to assume our share of responsibility and the privilege of propagating the Spirit-Fill Gospel of Christ Jesus by all available means, both at home and in foreign lands; and for this purpose we do hereby adopt the following articles of incorporation as our charter. Therefore we, the undersigned persons of the State of Florida, each being competent, hereby form ourselves and our successors into a corporation not for profit pursuant to the statues of the State of Florida.

ARTICLE I NAME

The name of this corporation shall be "EAGLE WINGS TEACHING MINISTRIES OF CHRIST, INC.-INTERNATIONAL", (Isa. 40:31, Act 2:42) with its principal place of business located at 913 E. 15TH Ave., Tampa, Florida 33605-3318, in the County of Hillsborough.

ARTICLE II PERPETUAL EXISTENCE

This corporation shall exist perpetually.

ARTICLE III MOTTO

"Until He Comes, Soar On The Power From The Knowledge Of His Word"

ARTICLE IV DAILY BIBLICAL MANDATE

Christ Jesus we preach, warning every man and teaching every man in all wisdom, that we may present everyman perfect in Christ Jesus. Knowing that those who wait on the Lord shall renew their strength: They shall Mount up with wings like eagles, they shall run and not be weary, they shall walk and not faint. To this end we also labor, striving according to His working which works in us mightily. (Col. 1:28, Isa. 40:31, Col.1:29)

ARTICLE V GENERAL PURPOSE

It shall be the purpose of Eagle Wings Teaching Ministries Of Christ, Inc.—International to spread the Spirit—Fill Gospel of Christ Jesus through biblical preaching, teaching bible—base academic curriculum and the teaching the Whole Counsel of God, to bring the unsaved to a saving knowledge of Christ Jesus; and to build up the saved in christian grace, victorious christian living and to have a vital part in carrying out the "Daily Biblical Mandate".

To this end we are united in one accord in fulfilling our "General Purpose" and "Daily Biblical Mandate" in the following manner:

- 1. Praise and Worship of God,
- Proclaim the kingdom message taught by Christ Jesus and His Apostles,
- 3. Proclaim the abiding present and power of the Holy Spirit in the life of the believer,
- 4. The power and authority of the believer,
- 5. Present salvation unto the lost,
- 6. Edify and unify the Body of Christ through a true presentation of the word (The Bible) and Christian Biblical Education,

- aid mankind and especially the household of Faith in the areas of religious, charitable, and educational needs,
- and perpetrate all the above to subsequent generations.

Since Eagle Wings Teaching Ministries Of Christ, Inc.-International is under the law and commandments of God, the members are constituted to obey the guidance and leadership of the Holy Spirit. In connection therewith or incidental thereto, this ministry shall have the right to do any and all things necessary for the furtherance of its vision, general purpose and daily biblical mandate in accordance with its constitution and By-laws (also known as "The Book of Fellowship).

ARTICLE VI PURSUANCE OF GENERAL PURPOSE

In pursuance to fits purpose but not limited to Eagle Wings Teaching Ministries Of Christ, Inc.-International shall through component ministries do business as Eagle Wings Teaching Ministries Of Christ Church, Eagle Wings Teaching Ministries Of Christ Fellowship, Eagle Wings Home Bible Study Fellowship, Solid Rock Christian Academy (Founded in 1986), Eagle Nest Pre-School Developmental Center, Eagle Wings Christian College, Eagle Wings Bible Institute of Ministry, Eagle Wings Vocational Training Institute, Eagle Wings Eagle Services Center, Wings Social Publishing, Eagle Wings Christian Books and Supplies, Eagle Developmental Services Academies Wings Christian and Ministries General Ministerial International, The Conclave of Eagle Wings Teaching Ministries Of Christ, Inc.-International, Eagle Wings Teaching Ministries Of Christ Retreat and Retirement Center.

ARTICLE VII HANDLING OF CORPORATION AFFAIRS

The affairs of Eagle Wings Teaching Ministries Of Christ, Inc.-International shall be guided by the Holy Spirit of God and The Book of Fellowship. The President (known also as General Watchman, Isa.62:6, Ezek.33:1-9, Ezek.3:16-21, Heb.13:17 and title as Presiding Bishop, I Tim.3:1-6) of the total ministry shall be authorized to administer binding judgment in all matters concerning the ministry as a whole. However he must seek counsel of the Executive Council every 90 days on all matters of the general and local ministry works. The Board of Directors, here after known as the Board of Executive Council shall make the final judgment in all matters of rules of order and conduct after all sides have been heard; the General Watchman shall only moderate this section (if not under question) with novote. The Senior Pastor of Eagle Wings Teaching Ministries Of Christ Church of (Headquarters Location) and the Presiding Bishop of Eagle Wings Teaching Ministries Of Christ , Inc. - International shall be one and the same person with the following exception.

The following exception maybe applied by majority vote of the Executive Council of Eagle Wings Teaching Ministries Of Christ, Inc.—International: the Assistant Pastor of Eagle Wings Teaching Ministries Of Christ Church of (Headquarters Location) may serve as General Watchman up to one year during the transition of a new Senior Pastor of Eagle Wings Teaching Ministries Of Christ Church of (Headquarters Location). If there is no Assistant Pastor, the Senior Pastor Emeritus of Eagle Wings Teaching Ministries Of Christ of (Headquarters Location) shall serve as General Watchman but he must step down as General Watchman when the new senior pastor takes office, (If no Senior Pastor Emeritus or if he is unable to serve the Executive Council shall appoint an Elder to serve).

If Eagle Wings Teaching Ministries Of Christ Church of (Headquarters Location), has an Assistant Pastor he or she shall also serve as General Representive for Corporate Affairs of Eagle Wings Teaching Ministries Of Christ, Inc.-International. It shall also be his or her primary function to be the personal representive of the General Watchman.

The Pastor of a Teaching Ministries Of Christ Church or a Teaching Ministries Of Christ Fellowship shall establish a Board of Local Executive Council within the church or fellowship. The Local Executive Council must follow the pattern of the Board of Executive Council of Eagle Wings Teaching Ministries Of Christ, Inc. - International, in all matters of decisions making.

ARTICLE VIII DECISION FOUNDATION

The decisions of all in leadership at any level within Eagle Wings Teaching Ministries Of Christ, Inc.— International must be founded on the "Word of God" or "The Book of Fellowship". If a decision(s) is made and found to be not in keeping with the Word of God or "The Book of Fellowship" then the decision shall not stand, NO EXECEPTIONS.

The delagates to the General Ministerial and Ministries Conclave (G.M.M.C.), shall have power to reverse all decisions that are not in keeping with the Word of God or "The Book of Fellowship" (by-laws) and remove any leader from office who continual to make decisions that are not in keeping with the Word of God or "The Book of Fellowship", NO EXCEPTIONS.

ARTICLE IX BOARD OF DIRECTORS

The Board of Directors shall consist of the General Watchman, General Representive for Corporate Affairs, General Secretary, General Treasurer, the Co-Founders and up to seven-at-large Pastors to be recommended by the

General Watchman and require the approval or disapproval of the Board of Directors and the Voting delagates to the G.M.M.C. of Eagle Wings Teaching Ministries Of Christ, Inc. -International, as govern by the by-laws.

The number of members to the Board of Directors of Eagle Wings Teaching Ministries Of Christ, Inc.-International, (Here after known as Board of Executive Council) must be kept uneven.

ARTICLE X

The Articles of Incorporation or By-Laws (Here after known as "The Book of Fellowship"), maybe amended as follows:

- 1. A special meeting requiring a 50% + 2 votes of two thirds of the Board of Executive Council members present to approve or disapprove the amending of By-laws or Articles of Incorporation shall be required.
- 2. A special meeting of the General Ministerial and Ministries Conclave (G.M.M.C.) to amend the By-laws or Articles of Incorporation shall be call only by the General Watchman after giving a ninety days notice to the delagates to the General Ministerial and Ministries Conclave (G.M.M.C.)
- 3. A 50% + 2 votes of members present to approve or disapprove the propose amendment to the Bylaws or Articles of Incorporation shall be required of delagates to the Annual General Ministerial and Ministries Conclave (G.M.M.C.). An approval vote mean that the amended by-laws or Articles of Incorporation will be enacted after 45 days of the close of the General Ministerial and Ministries Conclave (G.M.M.C.)

ARTICLE XI MAJORITY VOTE

A majority vote within the corporation shall be 50% + 1.
Exception to the 50% + 1 rule shall be Article X, subsection 1 & 3.

ARTICLE XII

A quorum within the corporation shall be no less than 1/3 of the voting members of the body at a duly call meeting of the body to conduct its business per the by-laws.

ARTICLE XIII CARE OF PROPERTIES

The care of properties of this corporation shall be coordinated by the Board of Executive Council under guidelines of the by-laws of this corporation. Local Ministries affiliated with Eagle Wings Teaching Ministries Of Christ, Inc.—International, may own property however an article of dissolution must be so written to permit the property to be given over to Eagle Wings Teaching Ministries Of Christ, Inc.—International, in the event there is a dissolution of the affiliated Ministry.

ARTICLE XIV

While maintaining its inherent right to sovereignty in the conduct of its own affairs, this Corporation shall seek and voluntarily maintain a cooperative Fellowship with other churches, fellowships, ministries and christian groups that are deemed mutually benevolent and beneficial to the vision, purpose and mandate of Eagle Wings Teaching Ministries Of Christ, Inc.-International.

ARTICLE XV CONTINUING SERVICE

The members and officers of Eagle Wings Teaching Ministries Of Christ, Inc. - International, shall be governed by the God given ministry vision given unto Donald A. Horne, Sr. and Ella M. Anderson-Horne as co-founders of Eagle Wings Teaching Ministries Of Christ, Inc.-International, in accordance with the Word of God and "The Book of Fellowship". As Senior Fastor and Pastor of Eagle Wings Teaching Ministries Of Christ Church of (location), Donald and Ella Horne, shall be voting members for life of this corporation. Donald and Ella Horne shall serve as members of the Board of Executive Council for Life. Donald A. Horne, Sr. shall serve as Senior Pastor of Eagle Wings Teaching Ministries Of Christ Church of (location) and General Watchman of Eagle Wings Teaching Ministries Of Christ, Inc. - International; Ella M. Anderson-Horne shall serve as Co-Pastor of Eagle Wings Teaching Ministries Of Christ Church of (location) and General Representive for Corporate Affairs until they move into_retirement. Upon retirement Donald and Ella Horne, shall receive no less than 70% of their individual salaries for life plus all other retirement benefits and have the right to appoint thier successor thereafter each successor shall come into office via "The Book of Fellowship".

ARTICLE XVI MEMBERSHIP

The membership of this ministry shall consist of two levels:

- A) Voting Member
- B) Associate Member

A) The level of Voting Member shall consist of persons who have accepted Christ Jesus as Lord and Saviour, having obeyed Him in the scriptural ordinance of Full Repentance of Sins, Baptism, the Lord Supper and who have entered into a firm and continuing commitment to the following Principles of Fellowship:

- (1) A member in good standing in a coopertive ministry or a satellite Teaching Ministries Of Christ Church or Fellowship that is in full compliance with the doctrine and order of Eagle Wings Teaching Ministries Of Christ, Inc. International.
- (2) Public and Private affirmation of the Covenant of Fellowship as set forth in the "The Book of Fellowship" (by-laws) and complete the new member orientation class as outline in the "The Book of Fellowship".
- (3) Regular attendance at all Weekday Power and Praise Service, Sunday Bible School, Sunday Power and Praise Service and conferences of Eagle Wings Teaching Ministries Of Christ, Inc.-International.
- (4) Participation in special Prayer and fasting services.
- (5) Giving of tithes and Love offerings to accomplish the work of Christ Jesus through, Eagle Wings Teaching Ministries Of Christ, Inc. -International and its affiliated ministries.
- (6) Recognition of his or her personal purpose in the Body of Christ and pursuit the fulfillment of that purpose.

(B) The level of Associate Member shall consist of persons who are interacting with the ministry in the following manner:

- (1) Employees of the ministry.
- (2) Students enrolled in an educational program of the ministry.
- (3) Persons who have accepted Christ Jesus as Lord and Saviour but are confine to a long term

Mental Health Center Facility, Nursing Home, Private Home, or Prison Facility (under regular ministerial care of Eagle Wings Teaching Ministries Of Christ, Inc.-International or one of its affiliated ministries).

(4) Abide by the doctrine, rules of order and the goals of Eagle Wings Teaching Ministries Of Christ, Inc.-International.

Membership into Eagle Wings Teaching Ministries Of Christ, Inc.—International or any of its affiliated ministries shall not be based on Race, Age, Sex, National origin or any other reason other than those given under the Voting member and Associate member section of Article XVI and by-laws of Eagle Wings Teaching Ministries Of Christ, Inc.— International, known as the "The Book of Fellowship".

ARTICLE XVII NAME ENDING

The name ending, "Teaching Ministries Of Christ Church", is resevered for a ministry ministering with the present of a structured congregational and "Teaching Ministries Of Christ Fellowship", is resevered for a ministry ministering without the present of a structured congregation (Parachurch Ministry) or with a congreation of less than twelve adult members in good standing.

ARTICLE XVIII FINANCIAL SUPPORT TO THE MINISTRY

All satillite Teaching Ministries Of Christ Churches, Teaching Ministries Of Christ Fellowships and affiliated ministries operating under the umbellar of Eagle Wings Teaching Ministries Of Christ, Inc.—International, 501 C3 status shall give monthly a tithe (10%) of its monthly income to Eagle Wings Teaching Ministries Of Christ, Inc.—International, for support of its general ministry operation and all ministries in fellowship with Eagle Wings Teaching Ministries Of Christ, Inc.—International (EWTMOC), shall also give \$1.00 per month from each of its members for World Evangelistic Teaching Outreach (WETO), Matthew 28:18-20.

Registration fees and free will offerings shall be the only additional fees to be required of those attending a conference, special meeting or workshop within Eagle Wings Teaching Ministries Of Christ, Inc. - International.

ARTICLE XIX PUBLIC WORSHIP

Meetings for public evangelistic teaching and worship shall be a minimum of one time a week or more when possible.

ARTICLE XX CORE BELIEF

Eagle Wings Teaching Ministries Of Christ, Inc.—
International is A SPIRIT-FILL EVANGELICAL RELIGIOUS,
CHARITABLE, and EDUCATIONAL MINISTRY who derives its
foundational teachings from the Spirit-Fill teaching of
Christ Jesus and His Apostles.

To that end Eagle Wings Teaching Ministries Of Christ, Inc.-International and its component ministries emphasizes:

1) All centers, churches and affiliated ministries are at liberty to choose its direction as set by the Holy Spirit through much prayer however all churches must be interdependent in cooperative works, rules of order and discipline with the New Testament being the Supreme Rule Book of the Eagle Wings Teaching Ministries Of Christ, Inc.— International and the Old Testament Bible the foundation of understanding God Jehovah and His plans for human kind.

Special Note: After 90 days if an affiliated ministry is still without a Pastor the General Watchman or his agent shall have the right to

appoint an Elder as full time Pastor of the ministry by personal appointment or agent after receiving the report of the recommendation committee.

Scripture key: Act 1:15-26; II Cor 8:19; Jo 14:26, 2 Peter 1:21; Act 16:6-10; Act 2:41-47; Act 4:32-37: I Cor 3:8-11; I Cor. 11:17-34; I Cor 14:26-40; II Cor 8:1-24; II Cor 9:1-15; II Thess 3:6-15: I Cor 5:1-13; Matt. 18:15-20; Act 17:11; Heb 4:12; Ps 68:11; I John 5:7; Isa 40:8; Deut. 8:3; Ps. 119:1-112

The baptizing of only those who have publicly Repent and Confess a personal faith in the person and teachings of Christ Jesus our Lord, as saviour of whosever (mankind). Re-baptizing of all who have only receive an infant baptism or those who have not been baptist "in the name ("by the authority of") the Father, the Son and of the Holy Ghost".

After baptism all new converts must be placed upon one year of special watch care to recieve the teachings of Christ Jesus and the ministry vision in order for the new convert to grow in words and deeds.

Scripture key: Rom 10:9; Matt. 28:20a; John 3:1-12; John 14:15, 21, 23-24; Matt. 7:24; Rom 15:18; Act 18: 24-28; Act 2: 38, 41; Matt. 28:19; Act 11:26.

3) All human beings have a "Free Will" to accept or reject the salvation that God Jehovah has given only through Christ Jesus our Lord and the hearer along is totally responsible for his/her actions.

Scripture key: St. John 3:14-21,36; Rom 1:18-32; Rom 2:16; Revelation 20: 12-13.

- 4) A believer can of his or her on "Free Will" through the cares of this world fall from the State of Grace and back into the State of Sin thus rejection of the Gospel teachings of Christ Jesus our Lord and if he or she remains in this state he or she will receiving the eternal punishment of the Lake of Fire and thus the second death.
- Scripture key: Mark 4:19; Luke 9:62; 2 Pet. 2:20-22; Heb 6: 4-6; Heb 12:14-17; John 3:1-21, 14:15-24, 15:1-10; Rev. 21:6-8; Luke 16:19-31; Rev.20:6, 11-15.
 - 5) There is a "Filling of Power" call "Fill with the Holy Ghost" (the speaking in tongues on the Day of Pentecost was a language gift from the Holy Spirit known by the hearer but unknown to the unlearned speaker). Without this gift of power the believer will not have the supernatural power to fully walk in the teaching of Christ Jesus, to "observe all things" and the Apostolic teaching given by Apostles.

Scripture key: Eph. 5:18; Matt. 3:11; Luke 3:16; Act 2:4%8, Eph 5:18, Act 2:1-41, 42-47; Matt 28:20; John 14:12.

6) There must be a separation of the Spirit-Fill Believer and the World. We are to be in the World to make disciples but not of it in our thinking or behavior, we are on a higher level.

Scripture key: Rom 12:2; 2 Cor 6:17; Matt 28:19-20; I Cor 6:2

7) The present of the "Fruit of the Spirit and active witnessing for Christ Jesus, is the true evidence of the ture present of the Holy Ghost in the believers life and thus "True Salvation.

Scripture key: John 4:24; Gal. 5:15-26; Act 1:8; I Jo. 4:1-21; I Cor 13: 1-13.

8) Male and Female believers alike are used of God Jehovah to preach/ proclaim the Spirit-Fill gospel (Good News) of the Christ Jesus our Lord, "The Christ of God".

Scripture key: Mark 16:15; I Cor 9:16 I Cor 1:17; Col. 1:28; Joel 2:28-32; Act 6:2,4; Eph 4:11; Act 21:8-9; Mt. 28; 1-10; Lk. 24:9-11; Jn. 4:28-30; John 20: 16-18; Luke 9:20.

ARTICLE XXI THE COVENANT OF FELLOWSHIP

As believers affiliated in christian love with Eagle Wings Teaching Ministries Of Christ, Inc.-International, our local Teaching Ministries Of Christ is comprised of baptize, Word-Living believers who are joined together in christian love in one common faith, belief and practice.

We believe in all the gifts of the Holy Spirit and that true evidence of being filled with the Holy Spirit is to have and exhibit all the elements of the fruit of the Holy Spirit through active Holy Living and personal witnessing.

We further believe that all Teaching Ministries Of Christ must be established through a true need and true desire to build a Teaching Ministries Of Christ Church or Fellowship to the glory of God the Father and Christ Jesus our Lord. No ministry shall ever be established as part of our christian body out of division as a result of anger.

We further believe that all internal disagreements within the Teaching Ministries Of Christ are to be settle within the Teaching Ministries Of Christ family with each member having the right to appeal to a council of Elders of the same faith. For any member to carry the internal disagreements of the Teaching Ministries Of Christ to a world court system is a violation of the Word of God and teachings of the ministry.

We further believe that the first work of the Teaching Ministries Of Christ is to evangelize the world through the gospel of Christ Jesus and secondly that the ministry must minister to the needs of all mankind and especially the household of faith. In all we do we must strive to show the seven fold purpose of the ministry, Christian Worship of the Father, Christian Obedience to the Lordship of the Son, Christian Submission to the Guidance of the Holy Spirit, Christian Loving Care shown to the uncared for, Christian Evangelism of the Unsaved, Christian Teaching of the untaught, and Christian Discipline shown in the lives of the redeemed. We further believe that the works of the ministry, its Pastor and the ministry staff are never to be supported by gambling means, gimmicks or selling within the sanctuary of the ministry but must be supported by the tithes and offerings of the saints.

We further believe that if a member who is in good health fail to attend services within a 30 day period, and or fail to partake of the Lord Supper within a 30 day period, and or fail to give tithes and a weekly offerings for the financially support of the ministry, and/or continue to violate the teachings of the ministry he or she shall not be a member in good standing and may have the righthand of fellowship withdrawn.

We further believe that when a member relocates, for whatever reason he or she should as soon as possible unite with another Teaching Ministries Of Christ Church or Fellowship of the same faith where they may carry out the spirit of this Covenant of Fellowship.

ARTICLE XXII OFFICIAL BIBLES

The official Bibles of Eagle Wings Teaching Ministries Fellowship Of Christ, Inc.—International, shall be, the Thomas Nelson Publishers, Personal Study Edition Bible, Number 165 for general uses by the congregation and clergy; The Thompson Chain—Reference Bible, for uses by the clergy for deeper analytical and synthetic system study of the Word of God.

NOTE; Any member of the clergy who desire to reference material from the "The Dake Annotated Reference Bible", may do so however the note section on Act 17:26 SHALL NOT be presented (preached or taught) as doctrine of Eagle Wings Teaching Ministries Of Christ, INC.-International, (see Article XVI).

ARTICLE XXIII BY-LAWS

The by-laws of this corporation shall be known "The Book of Fellowship" of Eagle Wings Teaching Ministries Of Christ, Inc.-International, of which these Articles of Incorporation shall be its core.

ARTICLE XXIV RESIDENCE AGENT

The name of the first residence agent shall be as listed and thereafter the residence agent shall be appointed by the Presiding Bishop-General Watchman.
