## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

### ARTICLE I NAME

The name of the corporation shall be:

### ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:

To promote justice and relieve the overworked, overcrowded court systems of the State of Florida by one of the following means.

- 1 Find and document any evidence that may/could show client is unjustly accused or charged in a court of law in the State of Florida either by ignorance, neglect, deceit, failure to report all the facts or failure to document and make known all facts that may have prevented an unjust charge being filed/reported in any court system in the State of Florida.
- 2 To deliver copies of such facts, photos, statements or other evidence to the State Attorney's Office, Public Defender, NAACP, ACLU, Bureau of Indian Affairs or any other organization as is required in order to promote justice.
- 3 To fully cooperate with any entity, agency or group in order to relieve our overworked, overcrowded court systems so that justice can prevail.
- 4 To harshly pursue and seek punitive damages from any individual, agency or group that ignorantly, neglectfully or deceitfully caused any such unjust accusation or charge being filed in the court system of the State of Florida.
- 5 To harshly pursue openly and politically the removal from office and seek punitive damages from any individual, agency, or group that had knowledge of any such ignorantly, neglectfully or deceitfully prepared court action and <u>compounded</u> the matter by either neglect or by deceitful act failed to stop such action as soon as possible to promote justice in the court systems of the State of Florida.
