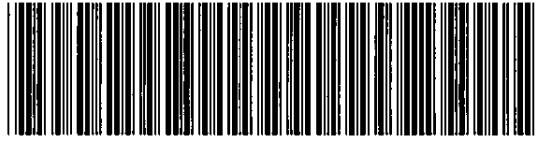


We were unaware that Ron Mowry had resigned as our agent as he still owns a townhouse here. We also never received the original notice to register a new agent.
