We the undersigned, do hereby associate ourselves together for the purpose of forming a corporation not for profit under the provisions of Chapter 617 Florida Statutes 617.0201, and do hereby adopt and declare the following chapter covering the existence and organization of this corporation.

ARTICLE I

The name of the corporation is the ESTERO ART LEAGUE., INC.

ARTICLE II

The general nature, objects, and purpose of this corporation is promote the interest and appreciation of visual arts to its members and the people of Estero, Florida and surrounding areas.

ARTICLE III

The organization is a non profit organization to promote the common interest in art under section 501 (c) 3.

ARTICLE IV

The qualifications for membership, the classification of members, and the manner of their administration together with the fees to be charged for such membership shall be determined by the Board of directors.

ARTICLE V

The corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE VI

The principal office of this corporation will be in Estero, Lee County, State of Florida.

ARTICLE VII

The officers who shall manage the affairs of the corporation and the time at which they shall be elected or appointed are as follows:

A President, Vice-President, Secretaries; Recording and Corresponding, Treasurer, Assistant Treasurer and a Board of Directors. The officers shall be elected at the March meeting. Installation of said officers will commence their terms in November. Each office will be held for a term of two (2) years.

A quorum must be present for the purpose of conducting the Annual Meetings. All vacancies occurring in the offices and other member positions that take place before the Annual Meeting or term end shall be filled by the remaining members or person predestinated as successor per office. No officer or member of the Board of Directors shall receive compensation for services as such.

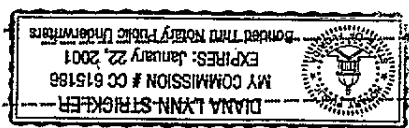
