We, the undersigned, do hereby join together in the formation of a corporation not for profit following the terms and conditions, to-wait:

ARTICLE I NAME

The name of this corporation is Running for Jesus Outreach Ministry Inc., 9412 Norfolk Blvd Jacksonville, FL 32208
The Registered Agent of the Corporation shall be Kelvin Brigman located at 9412 Norfolk Blvd., Jacksonville, FL. 32208

ARTICLE II

The general primary purpose for which this corporation is organized is to provide a Church, and Church facilities for its members, wherein the Doctrine of worship shall be restricted to the Holiness Doctrine, and in particularly as set forth in the Holy Bible, King's James Version, Acts 2:38 and in Colossians 2:9, to perform marriages, conduct Funerals, Baptisms, and like ceremonies.

ARTICLE III

The corporation shall not have any capital stock.

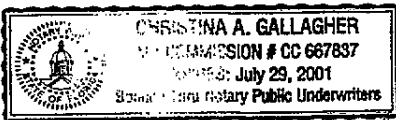

ARTICLE XI
THE ARTICLES OF INCORPORATION
of

In accordance with article (10) of our Articles of Inc. We hereby make the following amendment (c) from government form 503-4-351 (9-84) to comply with section 501 (c) (3) of the federal code:

A. Notwithstanding any other provisions of these articles, the purpose for which the corporation is organized are excluded, religious, charitable and educational within the meanings of section 501(c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

B. Notwithstanding any other provision of these articles this organization shall not carry on other activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

C. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code, or the Federal state or local government for exclusive public purpose.
