ARTICLE V - COMMENCEMENT AND DURATION

Organizacion Civica Cultural Dominicana "Ayudame" of Palm Beach County, Inc.

This organization will become effective as of March 3, 1999.

ARTICLE VI - PURPOSE

Organizacion Civica Cultural Dominicana "Ayudame" of Palm Beach County, Inc. was formed for cultural, social and recreational purposes in general, and specifically in uniting the Dominican Community within Palm Beach County, and maintaining and sharing their cultural heritage with other surrounding communities.

ARTICLE VII - ELECTIONS

The by-laws of Organizacion Civica Cultural Dominicana "Ayudame" of Palm Beach County, Inc. shall be adopted by the Board of Directors, and elections for office, such as President, Vice-President, Treasurer, and Secretary of the organization will be made by the Board of Directors and members which will occur through voting process given in the by-laws.

ARTICLE VIII - CAPITALIZATION, DISSOLUTION

Organizacion Civica Cultural Dominicana "Ayudame" of Palm Beach County, Inc. hereunder shall have no shares of stock or issue shares of stock. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and

distributions in furtherance of the purposes set forth in the article. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by the corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law. On the dissolution of this corporation, the board of directors shall dispose of all of the assets of the corporation exclusively for the purpose of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law, after paying or making provision for the payment of all liabilities of this corporation. Any assets not so disposed of by a court of competent jurisdiction in the county where the principal office of the corporation is then located exclusively for the purpose or to the organizations that the court determines are organized and operated exclusively charitable, educational, religious or scientific purposes.




