ARTICLES OF INCORPORATION

OF

BAKER COMMUNITY COUNSELING SERVICES, Inc.

Pursuant to the provisions of 617.1006, Florida Statutes, the undersigned Florida Non-profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST:

Amendments adopted are as follows:

ARTICLE II

Article II, Paragraph A shall be amended to read as follows:

- (a) To receive, hold, and disburse gifts and grants of money and property of every kind to administer the same for the development, maintenance, and operation of community counseling and education center and to do anything necessary or proper for the accomplishment of such purposes; and
- (b) To formulate plans, programs, and projects best suited for the maintenance and future growth of the counseling and education center.

ARTICLE III

Article III shall be amended to read as follows:

Membership of this corporation shall consist of seven (7) members who shall be known as trustees, and who shall collectively manage the affairs of the corporation as a governing Board. Six members of the Board of Trustees shall be divided equally into groups A and B. Trustees shall serve a term of two years with Group A beginning its term in even number years and Group B beginning its term in odd number years. The seventh member of the Board of Trustees shall be the Chairman who shall serve a one-year term following the two years of service on the Board of Trustees.

ARTICLE IV

Article IV shall be amended to read as follows:

The officers of the corporation shall consist of a Chairman and Vice-Chairman of the Board of Trustees, and such other executive officers as provided for in the corporate by-laws or required by law. The Chairman and the Vice-Chairman shall be elected each year at the annual meeting of the Board of Trustees.

SECOND: The date of adoption of the amendments was February 12, 2002.

THIRD: The members adopted The Amendments and the number of votes

cast for the Amendments was sufficient for approval.
