Pursuant to the provisions of Chapter 617, Florida Statutes, the undersigned not-for-profit corporation adopts these Articles of Amendment to Articles of Incorporation as follows:

- 1. The name of the corporation is Crosstown Center Association, Inc. (hereinafter the "Corporation").
- 2. The Document No. of the Corporation is N99000002012.
- 3. Paragraph C of Article VI of the Articles of Incorporation of the Corporation entitled "Board of Directors" is amended to revise subsection (iv) therein to read as follows:
