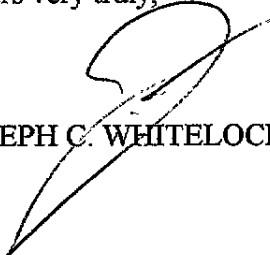

Articles Of Incorporation

The undersigned officers and directors of this Corporation each a natural person to contract, hereby make, file and publish these Articles of Incorporation, **not for profit** and notwithstanding any other provision of these Articles, this Corporation shall not engage in any transaction which is a prohibited transaction as defined in section 501 (c) (3) of the Internal Revenue Code of 1954, or the corresponding provision of any subsequent United States Revenue Code Laws.

Article I

NEW ASSEMBLE HOUSE OF PRAYER, INC.

The name of this Corporation, **not for profit**, is NEW ASSEMBLE HOUSE OF PRAYER, INC. and the initial principal office and mailing address is 900 22nd Street South, St. Petersburg Florida 33712.

Article II

Purpose

The purpose for which this Corporation is organized is for any lawful purposes authorized by section 501(c)(3) of the Internal Revenue Code of 1954 and the Florida Statutes

Article III

Membership

Persons and organizations shall be qualified to hold membership in this corporation as provided in the by-laws of this corporation.

Article IV

Corporate Existence

This Corporation is to exist perpetually.

Article V

Officers to Manage Corporation

The business of this Corporation shall be managed by the Board of Directors, which shall have the following officers: President, Vice-President, Secretary and Treasurer. These officers shall be elected at the annual meeting of the Board of Directors for a term of one year or until their successors are elected, and shall take office on the first day of January.

By-laws

The By-laws of this Corporation may be made, altered, amended, or rescinded at any regular or special business meeting by a two-thirds (2/3) vote; provided written notice of the intended change has been given to each Board Member at least two (2) weeks prior to the meeting at which the said proposed alteration, amendment, or rescision is offered for vote.

Article VIII

Amendment of Articles

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved at a regular or special business meeting by two-thirds (2/3) majority of board members present, provided notice of said amendment is given at least two (2) weeks prior to the meeting wherein the said proposed amendment is offered for vote.

Article IX

Dissolution of the Corporation

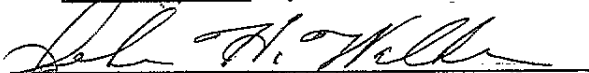
Upon dissolution of this organization, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or to the Federal Government, or to a State or Local Government, for a public purpose, and none of the assets will be distributed to any member, officer, or trustee of this organization.

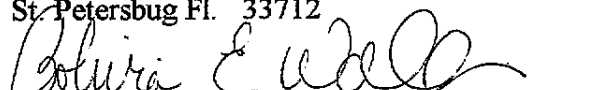
