ARTICLES OF INCORPORATION
FOR
New Hope Christian Methodist Episcopal Church, Inc.

ARTICLE ONE- NAME

The name of this corporation shall be: **NEW HOPE CHRISTIAN METHODIST EPISCOPAL CHURCH, INC.**

ARTICLE TWO - PRINCIPAL OFFICE

The principal place of business & mailing address of this corporation shall be: **11000 Sunnyhill Rd, Lake Iamonia Florida 32304-0000**

ARTICLE III PURPOSE(S)

The general purpose of **NEW HOPE CHRISTIAN METHODIST EPISCOPAL CHURCH, INC.**, hereinafter referred to as the Church, shall be to establish and maintain a place for the worship of Almighty God, to provide for Christian fellowship for those of like precious faith, to assume our share of responsibility and the privilege of propagating the Gospel of Jesus Christ by all available means, both at home and in foreign lands, all of which shall be carried out in conformance with the Doctrines and Discipline of the Christian Methodist Episcopal Church.

Membership in this Church shall be eligible to all those persons who offer themselves for Church membership, let the Preacher in Charge inquire into their spiritual condition, and receive them into the Church when they have given satisfactory assurances of their desires to flee from the wrath to come, and to be saved from their sins; and also, of the genuineness of their faith, and of their willingness to keep the rules of the Church. When satisfied on these points, the Minister shall bring the candidates before the Congregation, whenever practicable, and receive them according to the prescribed form. If a member in good standing in any other church shall desire to unite with us, such applicant may, by giving satisfactory answers to the usual inquires, be received without these formalities.

ARTICLE IV - MANNER OF ELECTION OF OFFICERS/TRUSTEES/DIRECTORS

The manner in which the Trustees are elected or appointed is:

The affairs of this corporation shall be managed by a Board of Trustees composed of four (4) persons and the following officers: President, Secretary and Treasurer. The Pastor of the Church, or Minister in Charge, shall be the President of the corporation. The Trustees, Officers, Pastor or Minister in Charge, shall be elected or appointed in accordance with the Doctrines and Discipline of the Christian Methodist Episcopal Church.

ARTICLE V - OFFICERS/TRUSTEES LISTED AS FOLLOWED

The Officers and Board of Trustees who will manage the business of this corporation until the first election of appointment as provided by the Doctrines and Discipline of the Christian Methodist Episcopal Church of until their successors are elected and qualified.

Additional By-laws may be adopted by the Church which are not inconsistent with or changed by a majority vote of the membership at the Quarterly Conference of the Church who are in attendance at any regular or special business meeting of the Church.

ARTICLE IX - AMENDMENTS OR CHANGES

These Articles of Incorporation may be amended or changed by a majority vote of the Quarterly Conference of the Church who are in attendance at any regular or special meeting called for that purpose.






