ONE:

The name address of this principal corporation is H.B.A. Youth Development, Inc. 2796 River Run Circle West Miramar, Florida 33025. The corporation is organized pursuant to the FLORIDA nonprofit Corporation Code.

TWO:

This corporation is a nonprofit Public Benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Child Care, Job Training, Job Placement, Land Acquisition Housing, Employment, Literacy. Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse

Awareness and Prevention, Tutoring, AIDS, Elderly Care and other

programs to aid to those in need.

THREE:

The duration of this corporation shall be perpetual, no stock

and shall have no members.
