ARTICLES OF INCORPORATION  
OF  
FIRST COAST NEUROLOGICAL SOCIETY, INC.  
A NOT-FOR-PROFIT CORPORATION

The undersigned, acting as the incorporator for the purpose of forming a not-for-profit corporation, pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I  
Name

The name of the corporation shall be: FIRST COAST NEUROLOGICAL SOCIETY, INC.

ARTICLE II  
Principal Address

The principal place of business and mailing address of the corporation shall be: 335 11th Avenue North, Jacksonville Beach, Florida 32250.

ARTICLE III  
Purpose(s)

The specific purpose(s) for which the corporation is organized are: continuing medical education for physicians in the Northeast Florida region, with special interest and/or expertise in the neurological sciences.

**Incorporators**

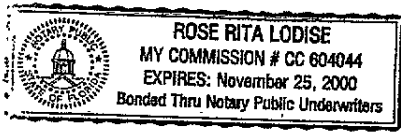
