#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Floridal Statutes, adopts the following articles of Incorporation for such corporation.

### ARTICLE I

The name of the corporation is New Attitude in Christ Jesus, Inc., the Chaplain Ross and Dorothy Hilton Prison Ministry.

# ARTICLE II

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.
