ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is New Attitude in Christ Jesus, Inc., the Chaplain Ross and Dorothy Hilton Prison Ministry.

ARTICLE II

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

ARTICLE III

The purposes for which the corporation is organized are for the practice of the Christian religion, through the worship of Almighty God and His glorious Son Jesus Christ, to carry out evangelistic efforts, including the following:

- A. To establish a consistent Pentecostal witness at each major penal institution within the West Florida District.
 - B. To present to state chaplains a referral system for:
 - 1. Inmates transitioning from incarceration to communities (Teen Challenge, local churches, etc.)
 - 2. Inmates and families for counseling, pastoral, hospital and home visitation.
 - C. To train and equip volunteers for ministry in prisons and ministry to inmates and their families;
- and any other activities deemed necessary and proper in keeping with the Christian faith.

ARTICLE IV

The qualification for members and directors and the manner of their admission or election are provided for in the bylaws.

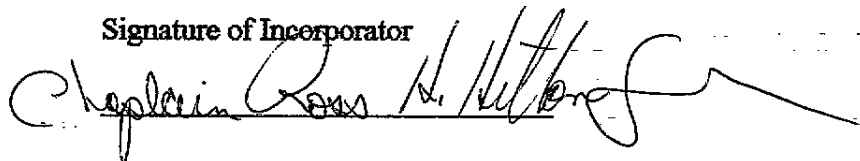
