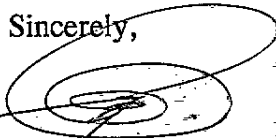

**ARTICLES OF INCORPORATION
OF
CENTRAL FLORIDA CMHC, INC.
A FLORIDA NONPROFIT CORPORATION**

The undersigned authority, acting as director of CENTRAL FLORIDA CMHC, INC., a Florida nonprofit corporation and pursuant to Chapter 617.1007, Florida Statutes, adopts the following Articles of Incorporation.

**ARTICLE ONE
CORPORATE NAME**

The name of the corporation shall be:

CENTRAL FLORIDA CMHC, INC.

**ARTICLE TWO
PRINCIPAL OFFICE AND MAILING ADDRESS**

The street address of the corporation's principal office and mailing address is:

**ARTICLE THREE
PURPOSE(S)**

The corporation is organized exclusively for charitable and educational purposes, including for such purposes, the making of distributions to organizations that qualify as tax exempt organizations under section 501c(3) of the Internal Revenue Code, or the corresponding section of any future tax code; the provision of community mental health services to individuals suffering from psychiatric illness; the coordination of such support services with official and voluntary health, welfare, educational, and rehabilitation agencies concerned with the prevention, control, and treatment of the physical, emotional, or mental problems of psychiatric illness; the encouragement and promotion of competent and comprehensive programs for the treatment of individuals afflicted with the physical, emotional, or mental problems of psychiatric illness; and the engagement in such other and further charitable or educational acts as may be necessary and proper to accomplish the foregoing objectives and purposes, provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code, or the corresponding section of any future federal tax code, and no part of the net earnings of the

corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

ARTICLE FOUR
MANNER OF ELECTION OF DIRECTORS

The Board of Directors shall be elected and appointed as stated in the by-laws of the corporation.

ARTICLE FIVE
CORPORATE POWERS

The corporate powers of this corporation are such powers as provided in Section 617.0302, Florida Statutes, provided, however, that no substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE SIX
NONSTOCK BASIS

The corporation is organized (and shall be operated) on a non-stock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type of stock, but may issue membership certificates if so provided in the by-laws.

ARTICLE EIGHT
DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501c(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

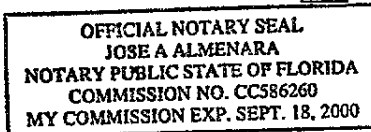

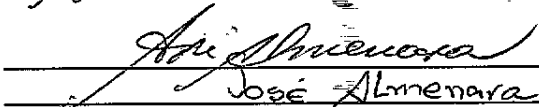
