ARTICLES OF INCORPORATION  
OF  
PROPHETIC REVIVAL MINISTRIES INTERNATIONAL, INC.

KNOWN ALL MEN BY THESE PRESENT:

That we, the undersigned, have this day associated ourselves together for the purposes of forming a non-profit corporation under and pursuant to the laws of the State of Florida and for that purpose hereby adopt these Articles of Incorporation.

ARTICLE I

The name of this corporation shall be: PROPHETIC REVIVAL MINISTRIES  
INTERNATIONAL, INC.

ARTICLE II

The principal place of business is 220 Sanchez Ave., Ormond Beach, Fl 32174, and mailing address of the corporation is: 1500 Beville Rd. 606-256, Daytona Beach, Fl 32114.

ARTICLE III

The specific purposes of this corporation is to do any and all lawful business allowed in the State of Florida as this corporation purposes:

1. To provide leadership and guidance to ministers who relate to our ministry nation wide.
2. To provide spiritual fellowship and communication in the atmosphere of revival.
3. To promote the idea of spiritual revival for the 21st century among churches and evangelistic organizations.
4. To assist ministers in the administration of their ministry, (ie. Evangelistic or pastoral).
5. To network different ministries together for the purpose-that Pastors, Evangelist or Prophetic ministry may interact with one another's ministry and churches.
6. To establish a ministry organization that will recognize credible and qualified ministry and issue proper ordination accordingly.
7. To work in conjunction with recognized and accredited Bible School Seminaries as to provide opportunities for our members, to further their Ministerial qualifications, providing a full range of Biblical degrees from Bachelor to Doctoral.

ARTICLE IV

The manner in which the directors are elected or appointed will be by the initial Board of Directors (founders) of Prophetic Revival Ministries International, Inc., which consist of the Executive Board Members of Gabriel Heymans Ministries. Dr. Gabriel J. Heymans will serve as life long President. Rev. Anita Heymans will serve as life long Vice President. The Board Members will appoint several other senior ministers in good standing to complete the Board of Directors for Prophetic Revival Ministries International, Inc. They will be appointed by unanimous vote. New Board Members will be appointed every two years by the unanimous vote of the the Executive Board of Directors of this Organization.
