ARTICLES OF INCORPORATION

OF

OSPREY CIVIC ASSOCIATION, INC.

A Non-Profit Corporation



The undersigned acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be OSPREY CIVIC ASSOCIATION, INC.

ARTICLE II

The office and mailing address of the Osprey Civic Association, Inc. shall be 224 Palmetto Avenue, Osprey, Florida 34229-9376.

ARTICLE III

The purpose of the Osprey Civic Association is to serve the public interests of the residents of Osprey, Florida, by establishing community based programs to:
