**ARTICLES OF INCORPORATION
OF CHURCH OF CHRIST IN GLENWOOD, INC.**

THE UNDERSIGNED INCORPORATOR FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA NOT FOR PROFIT CORPORATON ACT (PURSUANT TO SECTION 617.0202), HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I: NAME

THE NAME OF THE CORPORATION IS CHURCH OF CHRIST IN GLENWOOD, INC.

ARTICLE II: PRINCIPAL OFFICE

THE ADDRESS OF THE PRINCIPAL OFFICE AND MAILING ADDRESS OF THIS CORPORATION SHALL BE: 708 EAST 13TH STREET, PANAMA CITY, FLORIDA 32401.

ARTICLE III: PURPOSES

THE SPECIFIC PURPOSE(S) FOR WHICH THE CHRUCH IS ORGANIZED AS A CORPORATION IS: TO ESTABLISH IDENTITY UNDER THE BUSINESS LAWS OF FLORIDA TO ENHANCE ITS BUSINESS DEALINGS WITH FINANCIAL INSITUCTIONS; WHILE CONDUCTING RELIGIOUS ACTIVITIES DESIGNED TO TEACH ALL PEOPLE TO OBSERVE THE COMMANDENTS OF JESUS THE CHRIST, BAPTIZING THEM IN THE NAME OF GOD THE FATHER, GOD THE SON, AND GOD THE HOLY GHOST. (THE CHURCH, ACCORDING TO DEVINE SCRIPTURES, WAS ESTABLISHED BY THE CHRIST ON 33AD, ACT 2:41).

ARTICLE IV: MANNER OF ELECTON OF DIRECTORS:

THE CHURCH IS DIRECTED BY: (1) ELDERS AND DEACONS, WHICH ARE APPOINTED ACCORDING TO THE BIBICLAL TEACHING OF FIRST TIMOTHY, CHAPTER THREE AND TITUS CHAPTER ONE; (2) A PREACHER/MINISTER WHO IS EMPLOYED BY APPROVAL OF THE ELDERS/MEMBERSHIP, (3) IN THE ABSENCE OF ELDERS AND DEACONS, THE FAITHFUL MEN OF THE CHRUCH BECOME DIRECTORS, TOETHER WITH THE MINISTER, TO RESPONE TO SPIRITUAL TEACHINGS AND BUSINESS OF THE CONGREGATION.
