ARTICLES OF INCORPORATION
of

ARTICLE I

The name of the Corporation is "Descending Dove Ministries, Inc."

ARTICLE II

The Corporation is organized pursuant to the Florida Nonprofit Corporation Code.

ARTICLE III

The Corporation shall have perpetual duration.

ARTICLE IV

The Corporation will be organized exclusively for religious, charitable and educational purposes within the meaning of §501(c)(3) of the 1986 International Revenue code.

ARTICLE IV(a)

The purpose of the corporation is to give visible evidence of faith and fellowship to which God has called his people. To acknowledge ourselves to be a local manifestation of God's purpose of the universal church at which Jesus Christ ministered to the world to Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost: Teaching them to observe all things whatsoever I have commanded you: and, lo, I am with you always, even unto the end of the world. Amen. (Matthew 28:19-20).

Moreover, the corporation shall provide prayer and support for martial counseling for pre-marriages and existing marriages; provide adult and youth outreach and counseling; revivals; counseling and assisting alcoholics and drug addicts; and care groups to assist individuals spiritually, physically, and economically in the name of the Father, Son and Holy Ghost. In Jesus Name.

ARTICLE V

The method of election of the Corporation's directors shall be set forth in the Bylaws of the Corporation.

ARTICLE VI

Notwithstanding any other provision of these articles the corporation will not carry on any other activities not permitted to

be carried out by:

- (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law; or
- (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Internal Revenue law.

ARTICLE VII

The registered agent of this corporation is **Minister Herbert L. McNair, Jr.** whose address is 4254 Leo Lane # 114, Palm Beach Garden, Florida 33410.
