ARTICLES OF INCORPORATION FOR HOUSE OF THE LORD MINISTIES, INC.

ARTICLE I NAME

ARTICLE II PRINCIPAL PLACE OF BUSINESS

ARTICLE III PURPOSE (S)

The objective and purpose for which non-profit corporation is organized and constituted are as follows:

- A. To teach and implement the gospel of Jesus Christ throughout the United States and around the world as commanded in Mark 16: 15-16 (King James Version).
- **B.** To cooperate with other charitable organization, through grants and otherwise, which are working to develop a better life for economically dis advantage people. Following the example of the Jericho Road, teaching.
- C. To carry out love and healing Ministry of Jesus Christ through the distribution of bibles, teaching materials, preaching, clothing, food (prepared or unprepared).
