The undersigned subscriber to these Articles of Incorporation, does hereby form a corporation under the Florida General Corporation Act, Chapter 617, Florida Statutes...

ARTICLE I  
NAME OF CORPORATION

The name of this Corporation shall be SHERMAN HARPSTER LADIES AUXILIARY 1993, INC.

ARTICLE II  
GENERAL NATURE

The general nature of the activities of this Corporation shall be to promote, foster, service and represent American veterans and their families in the Venice-Nokomis, Florida area.

ARTICLE III

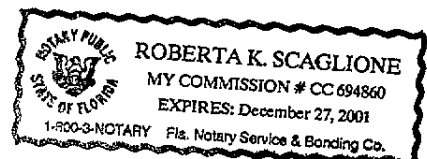

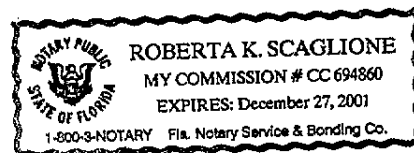

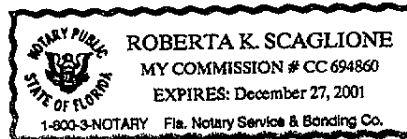
