ARTICLES OF INCORPORATION

OF

We the undersigned, hereby associated ourselves together for the purpose of forming a corporation not for profit, under Chapter 617 of the State of Florida, and in accordance with the following Articles of Incorporated:

ARTICLE I

The name of the Corporation shall be:

THE COMMUNITY HOLINESS CHURCH OF GOD FOR ALL PEOPLE, INCORPORATED and its principal place of business shall be in Hillsborough County, Florida, with the right to change and move said principal place of business within or without the State of Florida as the Board of Directors may from time to time deem proper.

ARTICLE II

The duration of this Corporation is perpetual.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida, shall be to do all things necessary whatsoever to collectively and spiritually encourage, guide and direct individuals towards a greater understanding of themselves and God by means of, but in no way limited to, education, worship, counseling, fellowship and community services; and to acquire, own, hold, manage, mortgage, improve, lease, sell, exchange, transfer, and otherwise deal with real, personal, and intangible property; and to engage in the transaction of any or all lawful businesses for which corporations may be incorporated pursuant to Chapter 617 of FLORIDA STATUTES and possess all the powers and rights granted under the Chapter.

ARTICLE III

The membership of this corporation shall constitute all

persons hereinafter named as officers and directors and such other persons as from time to time may become members by a majority vote of the existing membership.

#### ARTICLE VII

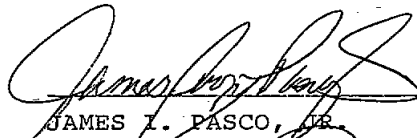
These Articles of Incorporation may be amended at a special meeting of the membership called for that purpose, by a majority vote of those present.

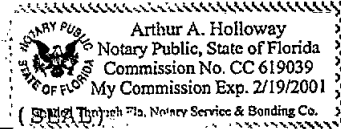
Amendments may also be made at a regular meeting of the membership upon notice given, as provided by the By-laws of intention to submit such amendments.

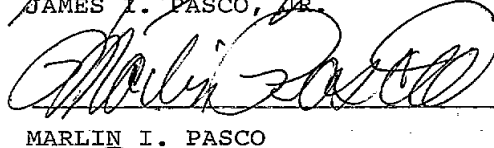
